- 1. To receive apologies for absence: Cllr Bradwell.
- 2. To receive declarations of interest. Councillors are invited to declare any relevant interests at this point or at any point during the meeting. As a neighbour to the property, Cllr Carmichael recused himself from the discussion on Silleys Field planning application.

- County Council Rural Broadband Scheme report from Clerk summarised as:

Eligibility: Applicants must be in a rural area (as classified by ONS) Only group projects are allowed (a group being 2 or more residents). Applicants must have current internet speeds below 100Mbps and not currently be gigabit capable. The Hampshire Top-Up to the Gigabit Broadband Voucher Scheme will be allocated on a 'first-come, first served' basis.

Funding available: Up to £3,000 is available per residential premises The voucher is to support the cost of installing new gigabit-capable connections only.

Applicants must commit to a 12-month contract with their supplier for downloads speeds of at least 30 Mbps through a gigabit-capable connection to get the funding.
