### 11. Any other business.

- The Councillors noted that, as predicted, the ash trees at Court Orchard had fallen over (into the bourne). Cllr Kirkcaldy explained that letters had been sent previously to the homeowner warning of this outcome.
- Tree Planting Cllr Kirkcaldy suggested that the village might support a scheme to plant an avenue of trees along the road from Toyd Corner into the village. Cllr Ash expressed concern about the action of overzealous hedge cutting, which would damage any saplings. Cllr Ash, therefore, suggested that villagers be given a tree for their gardens and that trees could also be planted in the Recreation Ground. Cllr Bradwell suggested that fruit trees also be included. ACTION: Cllr Kirkcaldy to investigate tree planting scheme/options.
- Church yard management. The Clerk reported that ecologist Clive Chatters had agreed to conduct an ecological survey of the churchyard at the end of May. ACTION: Clerk to arrange date and inform PCC.
