After some discussion the Councillors decided to respond under PAR5: We are happy to accept the decision reached by the District Council's Officers under their delegated powers, but expressed some concerns regarding light pollution, proximity to the public footpath, and the nature of a 'temporary' structure.

- Cllr Kirkcaldy reported that there would be road closures through the village:
8th – 10th August – Hampshire County Council – carriageway patching
8th – 19th August – Hampshire County Council – lay new road drainage
15th August – Openreach – access network in order to carry out pole test.

- Hampshire County Council – 20mph speed limit consultation. *The survey is available at: <https://www.hants.gov.uk/transport/transportchemes/20mph-speed-limits-consultation> and should take just 15 minutes to complete. It is open until midnight on Monday 12 September 2022.* Cllrs Kirkcaldy, Whitworth, and Carmichael reported that they had completed the survey.
- Cllr Kirkcaldy reported that there would be a 20-is-plenty road safety conference on Thursday 20th October in Oxfordshire at a cost of £95.00 plus travel & subsistence. Proposed: Cllr Broadbridge. Seconded: Cllr Carmichael.
