9. Payment of outstanding creditors

The Clerk presented the latest invoices and statement of accounts to the Councillors.

10. Potential CCTV Camera Trial

Cllr Wise has set up a meeting for Thursday 6th November at 7pm in the Village Hall. He will publish details on the Village WhatsApp group and on the Notice Board. SpeedWatch will also be covered at this meeting. Cllr Carmichael said that he had experimented with a Raspberry Pi and web camera. He was able to take pictures of number plates and store them. Cllr Wise felt that the quality would depend on light conditions etc. Cllr Wallis asked can you tell how fast the car is going? Cllr Carmichael said that he would not try to with this set up. Cllr Wise suggested that it would require some road markings or that an average speed could be calculated by using cameras at two points.

11. Users of Recreation Ground and Pavilion

Alderholt Youth Football Club have received their invoice for August and will shortly receive one for September. An arrangement has now been made between them and Rockbourne Cricket Club with regards to the cutting of the grass.

12. Working Groups (LGA1972 s7.48)

Cllr Wise said that another traffic watch group meeting had been held and they had also continued with SpeedWatch with pretty consistent results. 2% are over 35mph, which we report. Consistently 10-15% are over 30mph. The Police have now sent a spreadsheet of feedback. A few have been caught elsewhere as well. We are seeing between 100 and 200 vehicles per hour. Most speeding occurs on the peripheries of the rush hour times.

Cllr Wise also reported that there had been no further working groups on the Bourne.

Recreation Ground was discussed under Agenda Point 11.
